

# **Blacks Vets Stray Dog Policy**

# Information and guidance for finders and owners of Stray Dogs

When dealing with stray or lost cats, dogs, small furries and injured wildlife, the care of the pet/animal is our top priority.

We deal with stray pets/wildlife according to the law, the guidance issued by the Royal College of Veterinary Surgeons and the RSPCA. We consider the welfare of the animal and our ability to house them in suitable accommodation.

# Dogs with an up to date microchip

Following administering emergency care if needed we check for a microchip - if a chip is present, we make every effort to contact the owner or the microchip databases. If successful the owner will be asked to collect the dog bringing with them 2 forms of identification (for example passport, drivers licence, hard copy of utility bill or council tax bill), and at least one proof of ownership (for example Microchip number, vaccination card, details of your vet, adoption certificate, good quality clear photographs)

# Dogs without an up to date microchip

If a dog is not microchipped or we are unable to contact the owner possibly because the details are not up to date we will contact the local Dog Warden. It is a legal requirement that all non-microchipped dogs are reported to the warden.

We cannot hand over a non-microchipped dog to anyone except the Dog Warden. It is law in the UK that all dogs are microchipped and their details kept up to date. There are a high number of cases where pets are handed to potential owners which are later challenged by the real owners. We therefore take this approach to help ensure that the pet is returned to its rightful owner. We do not have the power to decide who owns the stray dog. We understand that you may find this frustrating if this is your dog and you are keen to be reunited, we would however ask that you consider how you would feel if your dog was handed to someone else based on evidence that is later proven to be unreliable. Photographic evidence is widely available on line and there are many cases where the pets have been lost for some time and the claimant can provide detailed information on the pet such as markings, gender or age. **What happens once the dog arrives at the kennels** (based on Stoke Kennels which is used by local authorities near to our Practices)

- The dog is checked again for a microchip (occasionally chips can migrate to a different part of the body) If an owner comes forward they are asked for identification and to confirm pet markings, distinguished features, gender, age and to provide photographic evidence.
- If needed dogs are microchipped before leaving, or the owner informed they must update microchip details if they are out of date.
- The kennels make a charge for their services to give you an example, Dudley MBCs charges are
  - Council Fine/Fees £50.00
  - Kennelling Fees £10 per day
  - Microchipping Fee £10
- If no one comes forward after 7 days the dog is put up for adoption. The finder can inform the kennels if they are interested in adopting the dog. The dog warden endeavours to place the dog in a rehoming centre.

# **Injured Dogs**

If you find an injured dog please contact the RSPCA first to register the case by calling 0300 1234999 the dog can then be taken to a local vet for first aid treatment. If injuries are critical please bring the dog to us as quickly as possible. If the owners cannot be found (Following the above process) the RSPCA will take over the care of the stray pet using the same log number.
